So far, \$7,275.00 have been pledged towards the Neighborhood Omni Watch Fundraiser, of that \$6,100.00 has been collected. There are still checks in the hands of board members that still need to be turned in, so that amount collected thus far will change. We are getting closer and closer to our projected goal of \$30,000.00.
