- a. President Melanie Loe

- b. Vice President Joseph Hernandez
  - 1. OOCCL Grant
    - 1. Joseph gave the news to the neighbors that Wynnewood was approved for the OOCCL beautification grant. The grant was in the amount of 2,300.00 dollars. This money will be used to go towards the cameras, as this was the part of the grant that they awarded the funds towards.
  - 2. Joining the OCCL
    - 1. Joseph stated that it would be in the neighborhoods best interest if neighbors would join the Old Oak Cliff Conservation League. We receive a lot of money from this organization and it would be nice if we could increase our membership in this organization to help support them in their efforts to improve and beautify Oak Cliff.

# j. Secretary –Jeremy Ratliff

- 1. Open Mic Neighbors have the chance to voice issues...
  - 1. Graffiti has been done at the Monssen Parkway Sign. Melanie stated she will contact Nancy Skinner to get this taken away with.
  - 2. Another neighbor has stated that perhaps pictures of the suspicious cars can be placed on the website to see what to look at. The neighborhood will check on the legality of this issue and the question was brought up about whether or not we want these people to know where the cameras are located based on the angles of these cameras.
  - 3. Melanie stated that the metallic green car that was involved in at least one burglary has now been painted maroon.
  - 4. Andy Shell has asked if we are going to move forward with the wine and cheese get togethers. This is a situation we will look forward to bring to the new board.
  - 5. Andy Shell brought up the idea that alleys would be an ideal location for cameras, and maybe those neighbors who want the cameras can get together and sponsor a camera. Each camera is about 1900 dollars for instillation. This would increase the monthly fees by about 10 dollars a month per camera.
  - 6. Joseph stated that many of the break ins in the neighborhood has been done by using the trash cans as a stepping stool. It might be a good idea that trash cans be moved into the perimeter of the lawn.
  - 7. Dwayne also spoke about the fact that many patrols for security by the VIP will not be made in alleys where their cars can be scratched. Please make sure that your alley ways are being kept clean so that VIP patrols can easily and safely patrol up and down the alley ways.
  - 8. Steve has asked that maybe donations for the legacy house be brought here to the general meeting.
  - 9. Buy Kroger gifts cards for the legacy house and get the credit for the neighborhood.

#### Attachment 1 -

The City Council voted to renew our <u>Sidewalk Replacement Program</u>. It is normally the responsibility of the homeowner to create and maintain a sidewalk. This cost sharing program assists homeowners in maintaining quality sidewalks within our neighborhoods.

- § The City will pay 50% and the homeowner will pay 50% for sidewalk replacement costs
- § The homeowner pays 100% for replacement of drive approaches
- § The City pays 100% for curb and gutter replacement (subject to bond program approval)

To qualify for this cost sharing program one must apply and get on the waiting list for future bond program funding. Applicants are considered on a first come first serve basis - the waiting list is currently over 1 year long. For more information on this program, please contact our Public Works and Transportation Department at 214-948-4650. I STRONGLY suggest you recommend this program to your neighbors. In the most recent council action, District 3 received only \$18,627 of the \$459,471 available......Oak Cliff, Mountain Creek, West Dallas, Kiest, and The Woods deserve more....but you and your neighbors need to be proactive and sign up.

Market City currently has minimal funding for the maintenance of our neighborhood alleys. The Council was briefed by City staff as to the current condition of our neighborhood alleys and various options about moving forward for maintenance and repair. The costs are enormous. I share this briefing with you to inform you well in advance of the City Council making a financial commitment for our alleys. I would appreciate your feedback.
